Terms and conditions for submission of Quotation/Expression of Interest for New Computer set and accessories etc. in the Assam Legislative Assembly Secretariat

Quotation/Expression of Interest should submit with the following documents. (Sl. 1 to17).

1. Copy of latest Trade License certificate.
2. PAN card.
3. Up to date annual income tax return statement for last 3(three) Financial year.
4. Financial viability certificate to be issued by the Public Sector Bank.
5. Firm registration Number (GST).
6. Up to date Sales tax and Income tax clearance certificate.
7. Experience of supply of New Computer Set and accessories etc. indicating annual turnover to any Govt. Office/Organization with details indicating the relevant years specifically.
8. Saving Bank A/C No.....with name of Public Sector Bank and Branch.
9. Earnest money of Rs.10,000.00 (Rupees ten thousand) only in the form FD/NSC etc. to be pledged in favour of Principal Secretary, Assam Legislative Assembly Secretariat.
10. Firm should furnish a declaration to the effect that he/she is willing and capable of rendering services/supply of articles at the rate offered by the Assam Legislative Assembly Secretariat after comparative study as per quotations/Expression of Interest.
11.
